Cooperative society

- <u>The cooperative society is an organization of</u> <u>non-profit-making by person and person's relations.</u>
- Everyone : one person for others person for everyone.
- 228 organizations are joining ICA from 90 countries in the world as of November, 2004 union members have exceeded over 760 million.
- ICA (international cooperative society alliance) is world's largest NGO (non-governmental organization) acknowledged to the United Nations.
- Japanese Consumers' Co-operative Union joins in 1952.

Japan cooperative (Outline)

- Type: Regional Coop, occupation Coop, university student association and medical treatment Coop
- Union members = 449
- Total union membership = 24.27 million of nationwide
- Business = about 3 trillion 391 billion yen of nationwide
- 6,975 articles and joint development COOP commodity = 373.9 billion yen
- 6.26 million COOP mutual aid people and 116 medical treatment Coop (76 places in hospital)



TOHTO CO-OP(Outline)

- Establish from consumers' wish that want to obtain the safer products in 1973.
- Union membership = about 225,000 families
- Business area: In Tokyo
- Total business = about 38.9 billion yen
- Fruit section = about 1.65 billion yen

<u>A basic philosophy</u> <u>"Producing straight - cooperation, democratic, the</u> <u>life and the living are defended."</u>

TOHTO(The "Sanchoku")

 Direct exchange information between producers and consumers → "Sanchoku"100%.

• <u>5 producing straight principles</u>

- 1) The harvest time is clear.
- (2) The production method and the shipment standard are clear.
- ③ Full agricultural cycle system.
- **④** Stable quality of delicious and freshness.
- **(5)** The consumer and the producer can be exchanged.
- (About 10,000 people/year visit the home and exchange it.)
- (The audit of opening to the public is held and confirm in every year.)



TOHTO(Commodity)



- Originally products information/week
- Many goods in stock more than 1000 items/week
- Story of product information.
- Merchandise information, locality information, recipe and Q&A etc.
- Vegetables and fruits independent, the standard is displayed by four stages according to the use level of chemical agricultural chemicals and the chemical fertilizer.

TOHTO(Original display why?)

- Display an original standard for producer's wish (to reduced pesticide) and consumer's wish (inform the fact correctly). Information disclosure to consumer (union member).
- The law and the standard that relates to vegetables and fruits include Agricultural Chemicals Regulation Law, the Japanese Agricultural Standard, Unfair Competition Prevention Law and the special cultivation farm products standard, etc.
- When a special display is done, the grounds are requested to be clarified (Prove).

With an agreement of contact, consumer are protected for the best goods.


TOHTO(Flow)


- A necessary number is filled in on the OCR order blank.

Composition ratio of "Food cost" expense per Tokyo family (%)




- Statistics from January to December, 2007

Composition ratio of "Fresh fruit" per Tokyo people family (%)




- Statistics from January to December, 2007

TOHTO(Banana Share)


Amount of banana supply (about 120 million) and share 28.9%)






JAPAN (Import fruit)


Composition ratio of import fruit (227.1 billion yen/year) (%)


JAPAN (Import banana)

Amount of banana import (CIF) 88.6% (60.8 billion yen) in the Philippines, 5.3% (6.7 billion yen) in Ecuador and 3.2% in Taiwan (2.2 billion yen)



JAPAN(Food self-support)

The self-sufficiency in food of the calorie base is 40%.
60% of Japanese meal is import products.

The breakdown of the violation is pesticide residue 66.1%, the microorganism inspection 21.0%, and the food additive 10.8%.

- The import number in 2006 is about 1.86 million.
- The inspection number when importing it was about 200,000 and the inspection rate was the entire about 10.7%.
- The violation of the Food Hygiene Law is 1,530.

(import number ratio =0.08%) (inspection number ratio =0.77%)



JAPAN(News)

- The event which distrust and the anxiety of food increase happens frequently and the society has come into question in Japan.
- Beef hamburg steak⇒It's mixing other meat by display as the beef hamburg steak.
- Kyoza⇒The health hazard is generated by high density agricultural chemicals mixing.
- Moji⇒It sells by using the returned raw material
- Farm products⇒The sales discontinuance, the commodity collection and found the pesticide residue make the import stop.

JAPAN(Import inspection)

• Monitoring system of food imports in three stages

Exporting country	Bilateral talk Hygiene measures of exporting country	(A) <u>Direction test</u> =Food with high possibility of violating Food Sanitation Law orders the inspection whenever importing it to those who import it.	
Import it	Examination of export written report Inspection when importing	(B) <u>Sampling inspection</u> =Historical earnings etc. are based and the food of each kind with low possibility of the violation is inspected.

JAPAN(Positive list system)

- <u>Making of positive list of pesticide</u> <u>residue standard=</u>All foods become control subjects.
- The residual standard of all agricultural chemicals was set. If the standard is exceeded, sales of the crops are prohibited.
- In the system before, there were a lot of agricultural chemicals which the residual standard was not set.
- A very severe, uniform, standard value named 0.01ppm(*) agricultural chemicals in which the residual standard value is not set in country and foreign countries (CODEX) is applied.

- Inclusive import prohibition regulations=Specific food in a specific country and the region can stop.
- When the violations were found from the food from a specific country and the manufacturer by the inspection when importing it, it came to be able to do the prohibition disposal of sales of the specific country and manufacturer's foods and the import, etc. by not each individual food but the batch.

(*)What are 0.01ppm?=Density dripped to pool of 25m with syringe by one drop

The entry point to Japanese market

No Delicious fruits that Japanese likes (sweetness and health).
 Fruit that cannot supply all year from Japan, import at off season.
 Better quality and lower price fruits than Japan.
 Importable fruit in steady quality.
 Fruit which is safe and can relieve it.
 Fruit that price is corresponds to quality (+ additional value).

- Japan is entering the age of declining birthrate and a growing proportion of elderly people. The quality and taste become more important.
- It grows up to the commodity that sticks to life and the expansion of the market scale is a balance situation of the quality (eating quality + additional value) and the price.



Case: Traceablity of banana



- Thai government (TISTR) promote "Productionharvest-shipment of banana" by construction of traceability system and Web information to consumer in Japan from Thayang Agricultural Cooperative that dealings for 19 years
- The promotion of a home together with the traceability and mutual understanding through the exchange with the consumer is the most important. 24
